# Aim and Scope of the Journal

Insights of Pakistan, Iran and the Caucasus Studies (IPICS) is a double-blind peer-reviewed multidisciplinary open-access academic journal (ISSN-Print: 2958-5112 and ISSN-Online: 2958-5120) published (previously bimonthly but now monthly from April 01, 2023) from Islamabad (Pakistan). The nature of its publication is quadrilingual, and it facilitates English, Urdu, Persian and Russian readers globally. The major site of research concerns Pakistan, Iran and the contemporary Caucasus – the independent states of Armenia, Azerbaijan and Georgia, and the North Caucasian republics and regions within the Russian Federation. Journal also covers, but are not confined to:

- The Kashmir Dispute
- Badakhshan region or Badakhshan/Pamir Mountain range
- Foreign relations between Pakistan, Iran, Azerbaijan, Armenia, Georgia and Russia
- Afghan political crisis and its impacts on Pakistan and Iran

- Socio-cultural ties among Turkic communities in Iran, Azerbaijan, Turkmenistan, Karakalpakstan Autonomous Region of Uzbekistan and other Central Asian Republics

**IPICS** aims to advance an area studies tradition in the humanities and social sciences about and from Pakistan, Iran and the Caucasus, connecting this tradition with core disciplinary concerns in the fields of modern history, political science, anthropology, cultural and religious studies, political economy, human geography, conflict and peace studies, and sociology. Research covering Pakistan, Iran and the Caucasus-related dimensions of South Asian, Central Asian, Middle Eastern and European politics, society, culture and history also fall within the remit of the journal **IPICS** publishes original research articles, review articles, policy discussions on strategic issues, interviews, biographical sketches, memoirs, archive documents, research notes, recent fieldwork narratives and book reviews.

# **Authors Guideline**

**IPICS** accepts manuscripts edited in accordance with its Author Guidelines. All submissions must be the original work of the author(s). Manuscripts are to be submitted in English and Urdu manually and electronically.

For manual submission, author(s) can send their manuscript via email at rehmatandmaryam@gmail.com where mail should also be CC to editor@rmrpublishers.org. On the other hand, Online Submission Process facilitates the author(s) to submit their manuscript electronically. Publishing in IPICS is not remunerated, however, some justified expenditures coerce the administration to receive defensible charges.

# Text

The manuscript is submitted as a Microsoft Word file without any specific graphical and typographical edits.

# Word Formatting Guide

The research study usually consists of an abstract, keywords, introduction, the present state of a topic, and analysis of the chosen area of research or interest, methodology, findings, discussion of the findings, conclusion, and references. The research study is usually structured into four parts: objective, method, results, and conclusions.

The format of the manuscript is by default a one column A4 with no text header, footer, and page numbering; all style tags are removed. Paragraphs are separated by a space, not tabs. As a font standard, Calibri 11-points is required. The whole text is left-aligned. Automated citations and links are not applied. All direct citations are italicized, however, the quotation marks themselves are not italicized.

A list of Notes is located in a separate section between the text and the final list of References. In the text, the number of the note is given in Arabic numerals in square brackets.

All images, tables and figures are attached separately, while their descriptions are marked and included in the text. All figures are provided in curves. All images are provided with copyright license granted to the publisher.

The total length of a paper, including images, tables and figures inserted into the text, should not exceed 10-16 pages (almost 4,000 to 6,000 words). However, the length of numerical, pictorial and/or statistical content is subjected to the opinion collected from the examiners during the peer review process.

# Abstract

The abstract contains a concise description of the objective(s), methodology and main findings of the paper. It is usually not longer than 250 words.

# Keywords

A list of up to six keywords or key technical expressions from a respective academic field should be provided separated by a semicolon.

## References

The submissions must follow the author-date system in accordance with the following edition of the APA Style

References at the end of a study are listed alphabetically. In the text, reference is given to the author's name (without initials), followed by the year of publication and page number(s) (both in parenthesis), e.g. (McGinn 2008, 12). Each in-text citation matches up with an entry in a reference list, where full bibliographic information is provided.

# About the Author(s)

The author(s) data include name, surname, degrees, affiliation, main professional achievements, professional headshot, and email of author(s). This information should be provided at the time of paper submission via online or manual "submission form".

## **Privacy Statement**

The names and email addresses entered in this journal site will be used exclusively for the stated purposes of this journal and will not be made available for any other purpose or to any other party.

## Instructions about First and Corresponding Author

As per the policy of **IPICS**;

- If the manuscript has been extracted from any thesis, only the research scholar has the sole right to be the first and corresponding author.
- If the manuscript belongs to any project, the project head has the authority to be the first and corresponding author.
- If the manuscript exhibits the joint working of multiple authors, the "Acknowledgement" section should be added in the manuscript that reflects the justified role of each author (along with the corresponding author) in the finalization of the research.
- In the case of a book review conducted by multiple authors, although it is necessary to present a critical analysis of each reviewer but an author who finally shapes the introduction, conclusion and references of critics' citations has the right to be the primary author.

The policy regarding Discourse Analysis and Travelogue is similar to the policy about Book reviews.

# **Call for Papers**

A vast area of research inclines the journal to publish quadrilingual (English, Urdu, Persian and Russian) **every month** since the decision taken by the RMR Administration on March 06, 2023. However, some important dates for each edition are as follows;

- Paper submission starts from the 2<sup>nd</sup> to 15<sup>th</sup> of each month.
- The review process continues in between 16<sup>th</sup> to 20<sup>th</sup> of each month.
- Revision Considers in between the 21<sup>st</sup> to 24<sup>th</sup> of each month.
- Acceptance Decision till the 25<sup>th</sup> of each month.
- Final Version till the 28<sup>th</sup> of each month.
- Publish Online on the 1<sup>st</sup> of every next month.

**Note:** Late receiving of revised papers would be reconsidered for coming editions. Author(s) will be intimated regarding paper status via email.

**Remember:** You can also submit book reviews, content analysis, conversation analysis, conference or seminar proceedings and/or travelogue. However, the nature of your work must be academic where citations must be in APA style, incorporated via automatic insert citation mechanism of MS-Word. Likewise, similar to the academic research paper, your submission must also contain an Abstract, Keywords, Introduction of your work, history of your work (if any), gaps in previously published literature (if any), your findings, your recommendations, and/or conclusion.

# **Contribution Cost**

IPICS publishes all articles in accordance with the open-access policy. In order to provide free online access to readers worldwide and to cover publishing costs, the journal does not receive any financial incentive from the author(s) but only collects;

- "Peer Review Process Fee" (the first time, and for each time if/when a revised version of the paper would be submitted for the next double-blind peer review),
- One-time "Editing cost" and "Paper Setting" which allows the editor(s) and designer(s) to ensure the theme, style and/or look of your paper as per the defined publication ethics or other requirements, and,
- One-time "Article Processing charges" (APC) that covers online publication cost.

There are no other charges except the justified ones, determined according to the forex rate fluctuation between the Pakistani rupee and the US dollar. Moreover, the journal's policy only allows the first/corresponding author to pay respective fees/costs/charges.

**Remember:** Charges once submitted would <u>never be refunded</u> even if the paper has been canceled and author(s) has been blacklisted by the editorial board **in case of proving any malpractice or violations of publication ethics.**

RMR Publishers as an exclusive initiative of Rehmat and Maryam Researches acknowledges, honors and applies all standards of Publication Ethics.

## **Publication Ethics**

RMR Publishers acknowledges, honors and applies all standards of publication ethics in accordance with general consensus as promulgated in HEC's Code of Conduct for Journals, and other catalogs of ethical standards. RMR Publishers refuse plagiarism of any kind.

By the very act of submitting articles to RMR Publishers, authors affirm that their contents are original and their article had neither been published elsewhere, nor it is under review for publication anywhere. The following duties are obligatory for authors, editors and reviewers associated with the RMR Publishers.

# **Duties of Authors**

**Reporting standards:** Authors of research studies should present an accurate account of their original research, whether theoretical or empirical, as well as an objective discussion of its significance. Fraudulent or knowingly inaccurate statements are unacceptable.

**Originality and plagiarism:** Authors should ensure that they have written entirely original works and they appropriately refer to works and/or words of other authors.

Remember; By submitting a manuscript to the journal, it is understood that it is an original manuscript, unpublished work and is not submitted elsewhere. Plagiarism, including duplicate publication of the author's own work, in whole or in part without proper citation is not tolerated by the journal. Plagiarism appears in various forms such as copying the same content from the other source; most commonly from the internet, copying elements of another author's paper such as figures, tables or illustrations that cannot be considered as common knowledge.

Self-plagiarism is also not allowed. Journal defines self-plagiarism as the intentional or unintentional reuse of one's own copyrighted work without citing the original source. However, this policy doesn't apply to the manuscripts presented/appeared in any conference proceeding from the author's side and an explicit reference is made.

# **Plagiarism Check**

Firstly, Journal checks plagiarism with the software recommended by HEC Pakistan. Secondly, it is checked manually by the team **IPICS**. If plagiarism is detected by the editorial/advisory board member, reviewer etc., at any stage of article process- before or after acceptance, during editing or at a proofreading stage, we will inform the same to the author(s) and will ask them to reconsider the content or to cite the references from where the content has been taken. HEC Pakistan has already set the acceptable limit of similarity index produced by the TURNITIN i.e. **19%**. If the similarity with different sources is more than 19% but less than 25% (With single-source not exceeding 5%), we prefer to send back the manuscript to the author and ask him to resubmit the paper after fixing that problem. But, if more than 25% of the paper is plagiarized, the article may be rejected and the same is notified to the author.

## **Plagiarism Detected after Publishing**

Sometimes, TURNITIN appears not very much efficient regarding the detection of plagiarism from the papers written in Urdu. In that case, if the plagiarism is detected manually and reported with proof after publishing, **IPICS** will conduct an investigation. In case if plagiarism is found, the paper may be formally retracted. The editor will write to the author(s), author(s)' institute and/or funding agencies about that and the paper containing the plagiarism will be marked "Plagiarism Detected after Publishing" (or similar statement) on each page of the PDF Copy. Moreover, author(s) will be banned for the next issues of IPICS as well as for the other journals published under Rehmat and Maryam Researches until resolving this issue.

## Plagiarism Undertaking

The authors must declare that their work is original at the time of submission. For this, an undertaking/acknowledgment form has been given in the Article Submission Form, stating that author(s) has not plagiarized any material and if found guilty he/they shall be solely responsible and IPICS reserve the right to take action against him/them. Author(s) is required to submit that form duly signed and stamped at the time of manuscript submission by Email to the **IPICS**. It's clearly stated that in **IPICS** 

Plagiarism Policy, if a paper has multiple authors, not only the principal author but also all the authors would be bound to take the responsibility of the plagiarism so they all would be required to submit the said undertaking/acknowledgment. While, in case of plagiarism found, author(s) would not only be blacklisted or banned from the journal but their names will also be displayed publicly on the journal website.

# Procedure for Appeal

Author(s) may appeal to the editor in case of;

- The rejection of a research paper during a blind peer review process.
- Notifying plagiarism in the paper and blacklist or banned the author(s)
- Someone's report of misquoting him/her in a paper.
- Objections to publications causing harm to any party.
- Infringement of Ethical boundaries in any manner.
- Extracting any part of the research from someone's thesis/dissertation without provable permission.
- The objection of someone other than the author(s) as he/she was also part of this research/project but his/her name is not mentioned in the author(s) list.
- Research traces as the part of someone's already finalized work, academic achievement or similar.
- Misuse of any reference until it is not interpretation, discourse analysis, or personal assessment drawn from the referred material.

Remember; author(s) have 20 days to address any objection, concern, report, or complaint. Otherwise, or however, Unsatisfied and/or unjustified answers authorize the editorial board regarding taking a decision to

- Notify traced issues/plagiarism on each page of your paper.
- Published a note about issue along with the title of your paper.
- Blacklist or banned the author(s) involved in violation of publication ethics and other policies defined by the journal, and publicized their names on the journal website.

**Data access and retention**: In case of research studies of empirical nature authors should provide raw data related to their manuscripts for editorial review, and they also must retain such data.

**Multiple publications:** Manuscripts based on the same research are usually published exclusively in only one journal. In case of an update or extension of a previously published article, a reference to the original publication ought to be explicitly acknowledged.

In justified cases, the Editorial Team may decide to publish a manuscript that had been previously published in another media, either in its original or modified form. Such cases include, for instance, an extraordinary contribution to human understanding of the matter provided by the article. Then an explicit reference to the original publication is made in the re-published paper along with copyright acknowledgements.

**Acknowledgment of sources:** Authors should acknowledge all sources of data used in their articles and refer to all publications they had been working with.

**Authorship of the paper:** Authorship should be limited to those who have made a significant contribution to the conception, design, execution, or interpretation of the study.

**Disclosure of financial support and conflicts of interest:** Authors should disclose any conflict of interest that might be construed to influence the results of their manuscript. Sources of financial support for the article should be also disclosed.

**Fundamental errors in published works:** If at any point of time, authors discover a significant error or inaccuracy in submitted manuscript or published work, then the error or inaccuracy must be reported to the Editor-in-Chief without delay.
